#### Dear Foster Parents:

The Department of Children and Families (DCF) is pleased to inform you that we have increased our reimbursement rates for foster care effective July 1, 2024, by an average of 3.6%. This increase over FY2024 foster care rates is intended to enhance support for our foster parents and to account for the cost of living in Massachusetts.

Effective July 1, 2024, the Department is also increasing the quarterly clothing as well as the annual birthday and holiday allowance rates for children in care. Quarterly clothing rates have increased by an average of 3.6%, while birthday and holiday rates have doubled over FY2024 rates. These increases are consistent with the language in the *Act to Protect Children in the Care of the Commonwealth*, passed by the Legislature in July 2008.

The new daily, quarterly clothing, birthday and holiday rates effective July 1, 2024, are as follows:

Age Range	Daily Rate	Quarterly Clothing	Birthday (Annual)	Holiday (Annual)
Ages 0-5	\$33.27	\$330.44	\$100.00	\$200.00
Ages 6-12	\$37.71	\$340.82	\$100.00	\$200.00
Ages 13+	\$39.40	\$410.02	\$100.00	\$200.00

The daily rates are effective for all children in departmental foster care on July 1, 2024. Quarterly clothing allowances will be first issued for all children in departmental foster care on August 15, 2024. The rates are not retroactive to a child's date of placement.

The Department encourages all foster parents to elect to receive payments via direct deposit/electronic funds transfer (EFT). To sign up for EFT, please contact your foster family social worker and request a blank EFT Authorization form. You may also contact the DCF Payment Assistance Line (PAL) at 1-800-632-8218 or by email at <a href="mailto:dcf.paymentassistanceline@mass.gov">dcf.paymentassistanceline@mass.gov</a>.

Likewise, we encourage all foster parents to register their e-mail on the **foster parent e-mail distribution list**. This distribution list allows us to better communicate directly with foster parents on matters that impact you and the children in your care. To register for the distribution list, please contact your foster family social worker.

Lastly, we continue to encourage all foster parents to sign up for the DCF Foster Parent Intranet Portal, FosterMA Connect, at <a href="https://www.mass.gov/how-to/fosterma-connect">https://www.mass.gov/how-to/fosterma-connect</a>. FosterMA Connect allows foster parents to view information about children in your care – including medical and payment information – as well as access to current policies, reimbursement forms, and information about upcoming events. Through FosterMA Connect, foster parents can ask questions directly to DCF staff and build a community of support with other foster parents.

DCF and the Commonwealth greatly appreciate the love, hope, and security you bring to children in foster care each and every day.
