- Services may be provided oneon-one or group therapy (direct therapy), or consultation services which includes talking with teachers to implement programs or adapting the classroom environment to meet a student's needs (consultative service).
- Services are provided during the school year with the potential for opportunity to participate in the extended school year (ESY) or summer school services typically run for a portion of the summer vacation and are based on the child's severity level and/or decline in skills without services.
- OTs will often collaborate with the teacher to ensure that the goals continue to be incorporated within the classroom. OTs may also communicate with family members for support at home.

Occupational Therapy Services: Clinic vs. School



Outpatient/Medical Occupational Therapy Services

- Services most often funded by an individual's insurance plan.
 Coverage for OT may require a prescription from the child's pediatrician.
- Outpatient OT services do not have any "eligibility criteria," but the treating therapist must demonstrate "medical necessity" for the insurance company to approve services.
- The scope of practice is broad and other areas outside of education can be addressed. This allows for more intensive, frequent, and focused therapy.
- Services are frequently offered year-round with no interruption to care in the summer months.
- There is typically more access to a variety of sensory and gross motor equipment in a clinic, as well as the ability to see a child in a more individualized setting.

School/Preschool Occupational Therapy Services

- Funded through the public school district and is based on eligibility guidelines for Individualized Education Plan (IEP) services or services offered through a school district's Multi-tiered System of Supports (MTSS).
- In the educational model, occupational therapy is considered a "related service." This means that in order for a child to be eligible for OT at school they must have an IEP.
- OTs support the child in the classroom environment and focus on the academic impact of the student's needs. Services and goals must be deemed educationally necessary.
- Services are provided during school hours in the setting that is considered "least restrictive."
